Police Report: Sgt Daryl Neit:

Daryl informed us that this will be his last night at TCC as Duty Sgt for Tuggeranong. He thanked Darryl Johnson and the MLA's & Carole Vincent (Bonython Neighborhood Watch) for their past help. He then introduced Sgt Jo Cameron as the new Station Sgt.

Sgt. Daryl Neit presented the following brief report on crime statistics and information regarding other local Police activities for the last month:

27 burglaries, 56 property damages, 20 assaults, 8 stolen motor vehicles, 12 registration plate thefts, 96 thefts, 23 arrests, 1196 incidents overall, 1st Feb to 28th Feb.

Sgt Jo introduced herself and told us Daryl's new job is in the Crime Prevention (Reduction) Area. Eric thanked Daryl for his services on behalf of the TCC.

Update from Local Members:

Mick Gentleman:

- Congratulations to Glenys on her work at TLC.
- He discussed his Community Work with Andrew Wall in regard to Vulnerable Road Users. Nicholas Clark CEO of Ancap believes the accident causing technology distractions, will be gone within the next 20 years.
- Water Quality. Simon Corbell will be visiting TCC in July to discuss the water quality & allocation of money, also the need for further testing in the area. Tuggeranong is a priority. ACT Government is also to put in 10%.

Andrew Wall:

- Cemetery still in the planning for 2020.
- CEO of Canberra Cemeteries Authority, Hamish Horn is still finalizing his market research into how much commercial interest there is in providing services for the cemetery. As in providing a crematorium or not, final report for the Government should be available soon.
- Solar Power Farm. Royalla is under way. Still waiting for Development Application for the one at Mugga Lane/ Monaro highway intersection. Likewise with Uriarra. They are both still in the planning stage. TCC is still waiting for feedback on the issues raised by TCC.

TCC PRESIDENT'S REPORT - 4TH MARCH 2014 GENERAL MEETING

On Sunday morning, the TCC and Tuggeranong Lake Carer's Group joined up for the annual Clean-Up Australia day. After the heavy rains, there was plenty of rubbish washed into the Lake. I dont know how many bags of rubbish were collected this year but Glenys will probably be able to tell us later during her report.

While I'm on the subject of the Lake, I sent out an email to members a few days ago about the joint Federal/ACT Government announcement. The Feds have finally committed to spending \$85million over 4 years to improve ACT's waterways. Glenys Patulny, in her capacity as Chair of the Southern ACT Catchment Group and I as TCC President co-signed a letter to Simon Corbell outlining some of our concerns and handed the letter to Simon at the announcement ceremony. He was able to allay at least one of our concerns in confirming that Lake Tuggeranong was actually included in the program. This was not clear from the information published in the Canberra Times. It seems that the results of water quality monitoring that has been ongoing for years has been put to one side because the first two years of the program apparently just involves water quality monitoring to establish baselines. So the start of any improvement works is at least two years off. This is disappointing. We will continue to press for works to start earlier. I invited Simon to talk to us about the program and he has agreed to do so at our July meeting. That will be a good opportunity for a frank discussion.

On a different topic, I mentioned at the last meeting that I'd been in contact with the Dept of Social Services manager responsible for their future accommodation project. This involves the possible relocation of 1,000 public servants out of Tuggeranong which would of course have a major impact on businesses in the Town Centre. At last meeting I advised that he hoped they would have a decision by this meeting. I spoke again to him yesterday - no decision yet, hopefully in time for the April meeting.

Another project the TCC is keeping an eye is the light rail. Two of our committee members have recently attended a seminar to keep across developments. The ACT Government is planning on spending a lot of money on this but, in my view, it has a lot of work to do to get the bulk of the Canberra community on side. I have invited Capital Metro to talk to us at the April meeting and will confirm later if this is happening.

Finally, I'd just like to congratulate Wayne King and his fellow Chisholm residents who have succeeded in convincing the Government that their unofficial park shouldn't be sold off for residential development but retained as a community park, to be named the Caroline Chisholm Park.
